The initial Consideration will be settled by the issuance of the Consideration Shares and, if any of the Earn-out Adjustments is triggered, the adjusted portion of the Consideration will be settled by the issuance of the Convertible Bonds. The issue price of the Consideration Shares shall be HK\$0.30 per share.
