UPDATE ON BORROWER'S DEFAULT OF LOAN
AGREEMENT

This announcement is made by New Sparkle Roll International Group Limited (the “**Company**”) pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap.571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 22 March 2021, 29 April 2022 and 8 December 2022 in relation to, inter alia, the 2nd Borrower’s default of repayment of the 2nd Loan (the “**Announcements**”). Unless otherwise stated, terms used in this announcement shall have the same meanings as those defined in the Announcements.

As disclosed in the Announcements, the Lender has commenced legal proceedings against the 2nd Borrower and the guarantor of the 2nd Loan (the “**Guarantor**”) in the High Court of Hong Kong for recovery of the 2nd Loan and other loss and damages. The Lender has on 6 December 2022 obtained a sealed judgment against the 2nd Borrower for the claims of the 2nd Loan and interest accrued thereon. The Lender has further on 17 February 2023 obtained a sealed judgment against the Guarantor for the claims of the 2nd Loan and interest accrued thereon.

The Company is now seeking legal advice in order to enforce the judgments against both the 2nd Borrower and the Guarantor and possible enforcement action may include commencing bankruptcy proceedings against the 2nd Borrower and/or the Guarantor.

The Company will make further announcement(s) as and when appropriate in compliance with the Listing Rules and inform the Shareholders and potential investors of any material development of this event.

Shareholders and potential investors are advised to exercise caution when dealing in the securities of the Company.
