This announcement is made by New Sparkle Roll International Group Limited (the “**Company**”) pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap.571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 4 March 2021, 1 April 2022, 29 April 2022, 8 August 2022 and 18 August 2022 in relation to, inter alia the Borrower’s default of repayment of the Loan and the subsequent settlement with the Borrower and the Guarantor by way of the Settlement Deed (the “**Announcements**”). Unless otherwise stated, terms used in this announcement shall have the same meanings as those defined in the Announcements.

Pursuant to the Settlement Deed, the Borrower shall pay the 1st instalment of the settlement sums in the amount of HK\$9,660,000 on 15 August 2022. After the Lender's demand and the subsequent request from the Borrower and the Guarantor (through their legal representative) for a short extension of time of payment on 22 August 2022, the Lender has received a cheque post-dated 29 August 2022 from the Guarantor through his legal representative today.

The Company will make further announcement(s) as and when appropriate in compliance with the Listing Rules and inform the Shareholders and potential investors of any material development of this event.
